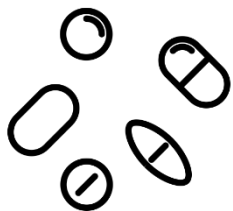
NO CLEAR BENEFIT

- Quality of life

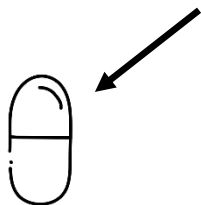
POSSIBLE BENEFIT

Individual medication

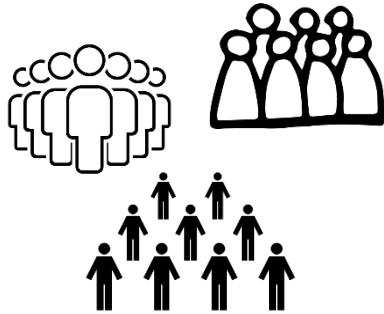
GENERAL FINDINGS

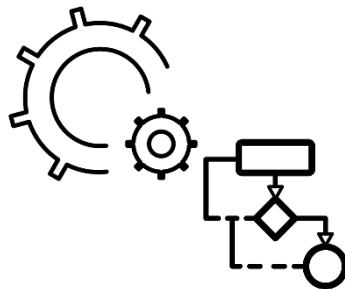

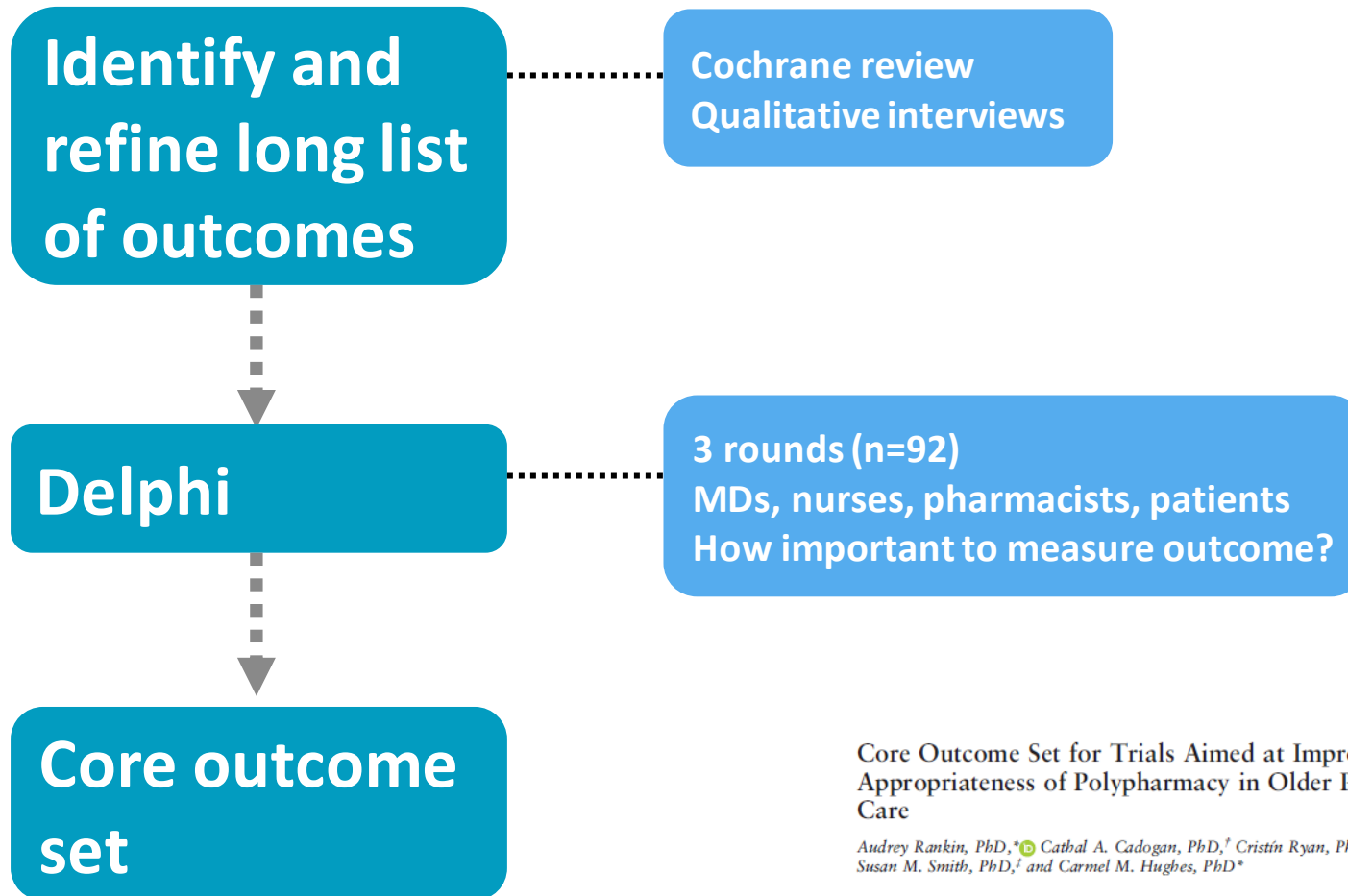

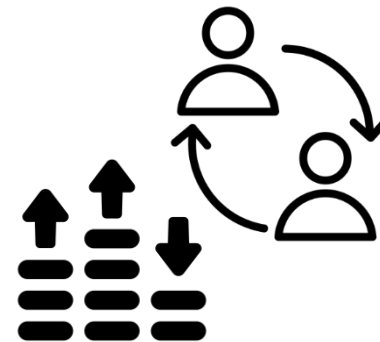

Study continuation versus discontinuation of long-term medications

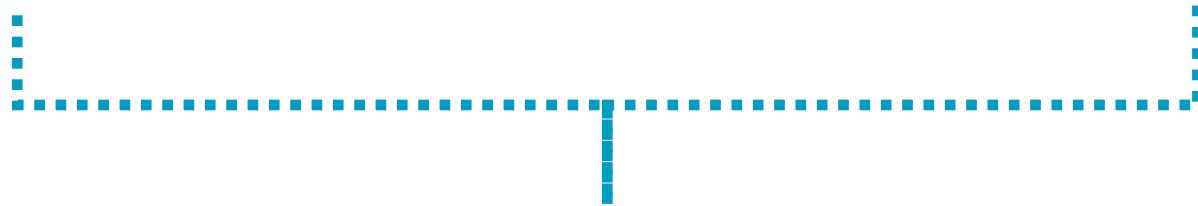
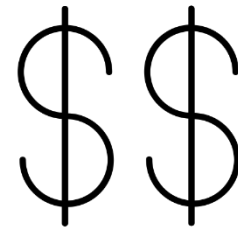
